**PROPOSED ISSUE OF S\$50,000,000 4.80% NOTES DUE 2018  
UNDER THE S\$250,000,000 MULTICURRENCY MEDIUM TERM NOTE PROGRAMME**

---

The Board of Directors of Koh Brothers Group Limited (the “**Company**”) wishes to announce that the Company intends to issue S\$50,000,000 4.80% notes due 2 January 2018 (the “**Notes**”). The Notes will be issued under the S\$250,000,000 Multicurrency Medium Term Note Programme (the “**Programme**”) established by the Company on 12 May 2014. The Hongkong and Shanghai Banking Corporation Limited has been appointed as the sole lead manager and bookrunner for the issue of the Notes.

The Company wishes to announce that it has priced the offering of the Notes and the principal terms of the Notes are as follows:

Issue Size	:	S\$50,000,000
Issue Price	:	100% of the principal amount of the Notes
Interest	:	4.80% per annum payable semi-annually
Maturity Date	:	3.5 years from the issue date of the Notes

The issue date of the Notes is currently expected to be on or about 2 July 2014.

The Notes will constitute direct, unconditional, unsubordinated and unsecured obligations of the Company and shall at all times rank *pari passu*, without any preference or priority among themselves, and *pari passu* with all other present and future unsecured obligations (other than subordinated obligations and priorities created by law) of the Company.

Pursuant to Condition 5(e)(ii) of the terms and conditions of the Notes, a “Change of Shareholding Event” will occur when Mr Koh Tiat Meng, Mr Koh Keng Siang, Mr Koh Keng Hiong and Madam Quek Chee Nee and their respective Immediate Family Members (as defined in the terms and conditions of the Notes) cease to own in aggregate (whether directly or indirectly) at least 35 per cent. of the issued share capital of the Company. Upon occurrence of a “Change of Shareholding Event”, each holder of Notes has an option to require the Company to redeem the Notes of such holder (subject to the terms and conditions of the Notes).

The Company intends to use the net proceeds from the issue of the Notes for the Group’s general corporate purposes, including financing investments, repayment of borrowings, general working capital and capital expenditure requirements of the Company and/or its subsidiaries.

The Notes will be offered by the Company pursuant to exemptions invoked under Sections 274, 275 and/or any other applicable provisions of the Securities and Futures Act, Chapter 289 of Singapore.

Application will be made to the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) for permission to deal in and for the listing of and quotation for the Notes on the SGX-ST. Such permission will be granted when such Notes have been admitted to the Official List of the SGX-ST. Approval in-principle from, admission of the Notes to the Official List of, and listing and quotation of any Notes on, the SGX-ST are not to be taken as an indication of the merits of the Company, its subsidiaries, its associated companies (if any), the Programme or such Notes. The SGX-ST assumes no responsibility for the correctness of any of the statements made, opinions expressed or reports contained herein.
